ORDINANCE TO ADOPT THE GENERAL ALIMONY MILLAGE RATE FOR ALL PROPERTY SUBJECT TO TAXATION BY THE TOWN OF ST. FRANCISVILLE IN WEST FELICIANA PARISH FOR TAX YEAR 2023.

SECTION 1: BE IT ORDAINED by the Mayor and Board of Aldermen of the Town of St. Francisville, Louisiana, in regular and legal session convened, that the Town of St. Francisville of the Parish of West Feliciana, Louisiana, in a public meeting held on May 9, 2023, which meeting was conducted in accordance with the Open Meetings Law and the additional requirements of Article XII, Section 3 of the Louisiana Constitution and R.S. 42:11 – 28 [R.S. 42:11, et seq.] that the following millage rate(s) be and they are hereby levied upon the dollar of each assessed valuation of all property which is subject to ad valorem taxation within said Town for the year 2023 for the purpose of raising revenue:

5.660 mills

SECTION 2. BE IT FURTHER ORDAINED that the proper administrative officials of the Parish of West Feliciana, State of Louisiana, be and they are hereby empowered, authorized, and directed to spread said taxes, as hereinabove set forth, upon the assessment roll of said Parish for the year 2023, and to make the collection of the taxes imposed for and on behalf of the taxing authority, according to law, and that the taxes herein levied shall become a permanent lien and privilege on all property subject to taxation as herein set forth, and collection thereof shall be enforceable in the manner provided by law.






