

ORDINANCE 2024-6

ABANDONMENT OF A PORTION OF FLORIDA STREET WITHIN THE TOWN OF ST.  
FRANCISVILLE

AN ORDINANCE vacating, revoking, and setting aside the dedication to public use, a portion of the following street in the Town of St. Francisville:

WHEREAS, the below described Florida Street is deemed no longer to pose a public purpose or benefit for the Town of St. Francisville; and

WHEREAS, the below described portion of Florida Street is causing possible exposure of liability to the Town of St. Francisville; and

WHEREAS, the benefits of abandoning the below described portion of Florida Street greatly outweighs the cost of retaining the street;

By the Mayor and the Board of Aldermen of the Town of St. Francisville, Louisiana, in a regular meeting convened with a quorum present on the 28th day of May, 2024 and introduced then this ordinance and published such pursuant to statute prior to holding a public meeting on the 11<sup>th</sup> day of June, 2024, at which time said ordinance was adopted, and all necessary procedure was followed thereafter;

BE IT ORDAINED that, having been abandoned in fact, and in truth and in fact, having not been used as a public street or for a public purpose, and being no longer needed for public use, the portion of Florida Street that is so abandoned is located in Section 44, 73S-R3W, Greensburg Land District, being situated West of Prosperity Street, and comprises 0.62 acres situated is Square 8, as more fully shown on that certain Map of Survey & Topography of Lots 4, 5, 6 & E1/2 Lot 3, Square 8, Town of St. Francisville & 0.131 acres Louvenia M. Veal Property by L & L Land Surveying, Inc. and certified by F. Dewitt Ladner, Professional Land Surveyor, a copy of which is attached hereto and made a part hereon as Exhibit A.

The above-described portion of Florida Street is abandoned in favor of the owners of the adjoining property.

**BE IT ORDAINED** that this ordinance shall become effective immediately.


