

## **ORDINANCE 2025-6**

### **AN ORDINANCE TO ESTABLISH SPEED LIMITS WITHIN CERTAIN SUBDIVISIONS IN THE TOWN OF ST. FRANCISVILLE, LOUISIANA**

**WHEREAS**, the Town of St. Francisville has the duty and responsibility to promote the public health, safety, and general welfare of its residents and visitors;

**WHEREAS**, the Town of St. Francisville maintains authority over its municipal streets and roadways, including those within established subdivisions;

**WHEREAS**, the regulation of vehicular speed on municipal roadways is necessary to ensure the safe and orderly flow of traffic and to protect pedestrians, children, and residents in residential neighborhoods;

**WHEREAS**, the Town recognizes the need to balance traffic flow with public safety, and desires to establish consistent and enforceable speed limits within subdivisions to reduce the risk of accidents and improve quality of life;

**NOW, THEREFORE, BE IT ORDAINED** by the Board of Aldermen of the Town of St. Francisville, Louisiana, that a 15mph speed limit be set in the following subdivisions:

**Audubon Hills, Dipple #1, Dippel Section #2, Pecan Grove Plantation, Martin, and Villa Rose**

**BE IT FURTHER ORDAINED**, that the speed limits set forth above shall remain in effect unless or until modified by a Resolution duly adopted by a majority vote of the Board of Aldermen at a properly noticed and quorum-present meeting.

**BE IT FURTHER ORDAINED**, that this Ordinance shall take effect immediately upon publication in the official journal of the Town of St. Francisville in accordance with applicable law.

This Ordinance having been submitted to a vote, the vote thereon was as follows:




