### **OLD BUSINESS:**

- Motion was made by Brandon Branch, seconded by Peggy Gammill to approve the wrought iron 3ft high fence and design that will be around the Live Oak tree along the parking lot entrance, Fidelity St and the back side of the tree as shown on the plat dated May 12, 2025 for the property located at 4727 Fidelity St. All in favor, none opposed. - Motion was made by Peggy Gammill, seconded by Brandon Branch to approve the revisions to the existing fence located at 9827 Royal St. The new fence will be a wooden privacy fence right side and rear 6ft tall, left side 6ft to step up to 8ft to match neighbors with an 8ft between the house and property line on left side.
